<sup>4)</sup> No fee shall be charged for applications regarding the naturalisation of children below the age of 18 provided the parents – or one of these – were born Danish or have subsequently obtained Danish nationality.

<sup>5)</sup> Where several documents are issued together to the citizen, a total fee of DKK 200 shall be charged.

<sup>6)</sup> Provided the request for VAT refund comprises several separate purchases, a fee of DKK 200 shall be charged per statement.

<sup>7)</sup> Where several provisional passports or extension of passports are issued at the same time, a fee of DKK 2,355 shall be charged for the first passport and DKK 1,010 for subsequent passports.

<sup>8)</sup> Where several provisional passports or extension of passports are issued at the same time, a fee of DKK 3,365 shall be charged for the first passport and DKK 1,010 for subsequent passports.
